

Rules & Regulations

- 1. The rules and Regulations of MSLTA will govern the tournament
- 2. The Code of conduct of MSLTA will strictly be enforced.
- 3. No entries will be accepted on the phone or through some other person.
- 4. The Tournament committee reserves the right to refuse any entry without assigning any reason.
- 5. MSLTA approved Tennis Balls will be used.
- 6. Consultation with Director the MSLTA supervisor may postpone any match on the account of insufficient light or adverse weather or court conditions. In all such cases the score and previous occupancy of the court shall hold good.
- 7. The organizing committee will entertain no complaints in connection with the tournament unless made in writing by the participant and lodged with the MSLTA Supervisor within 2 hours of the occurrence of the cause of the same.
- 8. Competitors must report to the referee at least 15mins before the schedule time of any match. Participants failing to report within the scheduled time of any match may be defaulted. The players must also ascertain from the referee about their next match. The Tournament Director & MSLTA Supervisor will be the final authority regarding walk-over.
- 9. No request for postponement, deferment of any match will be entertained and the defaulting player will be defaulted. However, the MSLTA Supervisor holds the discretion to postpone or pre-pone any match if he so requires, without assigning any reasons.
- 10. For the daily schedule of matches, the players in their own interest will ascertain the required information for notice boards.
- 11. For seeding purposes MSLTA ranking points and current performance will be considered.
- 12. The Tournament Organizing Committee is the final deciding fact regarding decision on players injuries/walkovers/violations/bad behavior etc...
- 13. The list of players in the Main Draw and Qualifying Draw will be displayed at the MSLTA website www.mslta.org. and at Ravine Hotel on the Notice Board. The Players intending to play the tournament, should check their names and points, in the main and qualifying list and should contact tournament director for any clarifications in the matter of points missed entries etc.
